The Affiliated Church/Ministry Agrees to support, attend and participate in each day of the Annual Holy Conference held in the first week of November each year.

The Affiliated Church/Ministry is connected with Ambassadors For Christ Of The Living God Ministries, Inc. for the purpose of advisement, training, fellowshiping, and growing within the Embassy.

By signing this Agreement, the Affiliated Church/Ministry understands that it does not have to change its name, but it is believed and expected that the Church/Ministry should claim and/or announce its affiliation or membership with Ambassadors For Christ Of The Living God Ministries, Inc. (AFC Embassy) as its Headquarters Church.
